## **RESOLUTION NO. 14-31 Authorizing the Purchase of Upgrading to Dual Frequency Side Scan Sonar for FireStorm 36 Fireboat, Marine 61-1**

WHEREAS, The Commissioners of Fire District No. 2, in the Township of Lower, County of Cape May, are charged with the responsibility of providing fire fighting within Fire District 2, Lower Township; and,

WHEREAS, Said Commissioners of Fire District No. 2, are the owners of a FireStorm 36 fireboat with low frequency side scan sonar; and,

WHEREAS, The acquisition of high frequency side scan sonar coupled with the existing low frequency side scan sonar is an excellent combination for general purpose side scan work. The low frequency unit would be used when large search areas are involved, once the target is generally located, the high frequency unit is used to make close passes to produce high resolution images of the target for analysis; and,

WHEREAS, Fire District No. 2, Lower Township has received a quote dated September 18, 2014 from JW Fishers MFG., Inc, E. Taunton, MA, in the amount of \$11,368.00 to upgrade the existing single low frequency side scan sonar to dual frequency side scan sonar, including one day factory training (1/2 day classroom and 1/2 day on the water)

WHEREAS, there are remaining funds held in reserve from the insurance payment from the sinking of the Robert C., designated Marine 1 (See Resolution 12-37) are available and are sufficient to pay for this upgrade purchase; and,

WHEREAS, The Commissioners of Fire District No. 2, Lower Township are desirous of purchasing this upgrade in the amount of \$11,368.00;

NOW THEREFORE BE IT RESOLVED that the appropriate Commissioners are authorized to sign the necessary documents required to execute the purchase the upgrade quote dated September 18, 2014 from JW Fishers MFG., Inc, E. Taunton, MA, in the amount of \$11,368.00 to upgrade the existing single low frequency side scan sonar to dual frequency side scan sonar, including one day factory training (1/2 day classroom and 1/2 day on the water)
